BIOGRAPHICAL/HISTORICAL NOTE

George Reynolds Boyle was the geologist who discovered the Sam Fordyce oil field near Sullivan City, Texas. It was the first oil field in Hidalgo County.

Boyle was born in Dublin, Texas, in 1899. His family moved to San Benito when he was a child, and he graduated from high school there. He attended Harvard University where he earned a degree in geology.

When he returned to the Rio Grande Valley, Boyle married attorney Willie Zac Drummond. They spent four years in Venezuela before settling in Mission, Texas. In Mission Boyle worked as an independent petroleum geologist covering the counties of Hidalgo, Starr, and Zapata.

In 1936 Boyle bought the Hotel Ringgold in Rio Grande City. He was a charter member of the Rotary clubs in Rio Grande City and Mission. He was an amateur historian in the Starr County area.

The Boyles had two children: a son William and a daughter Barbara. Boyle died in 1986 in Dallas, Texas and is buried in the Laurel Hill Cemetery in Rio Grande City, Texas.
