Pharr, Texas was established in 1909 by Henry Newton Pharr and John C. Kelly. It is located in the southern part of Hidalgo County, which was once part of the Juan Jose Hinojosa land grant. The city was incorporated in 1916.

SCOPE AND CONTENT NOTE

The collection is comprised of two typewritten lists of the City of Pharr, Texas officials from 1916-1986. The officials included on the lists includes mayors, commissioners, marshals, city attorneys, treasurers, city secretaries, city clerks, health officers, fire marshals, water superintendents, auditors, pound masters, janitors, street cleaners, utilities personnel, insurance agents, fire chiefs, police chiefs, municipal judges, parks and recreation personnel, municipal court bailiffs, and librarians. The title of each office and the person filling the office is listed for each year.
