BIOGRAPHICAL/HISTORICAL NOTE

Oliver Cromwell Aldrich, Sr., was born in Crockett, Houston County, Texas on January 5, 1887 to Willie (Arledge) (1862-1959) and Armistead Albert Aldrich (1858-1945). His father was an attorney and county judge in Houston County. His siblings were Albertine (Aldrich) Von Doenhoff (1883-1970), Hallie Harriet (Aldrich) Rigsby (1889-1936), Mary Elizabeth Aldrich (1895-1977) and Henry Masters Aldrich (1900-1904).

Aldrich graduated from Crockett High School and Austin College at Sherman. He earned his LLB degree at the University of Texas law school in 1912 and was also admitted to the bar that year. He joined the Crockett law firm of Aldrich, Crook and Aldrich. The other lawyers in the firm were his father and George Whitfield Crook.

During World War I Aldrich organized a volunteer company which became U.S. Army's Company E, 143rd Infantry Regiment from Texas. As First Lieutenant he served as the commanding officer. The Regiment saw action in the Meuse-Argonne sector in France from October 7 to 28 in 1918.

Aldrich married Anne Saunders King (1895-1975) on October 12, 1917. They had three sons: Oliver Cromwell Aldrich Jr. (1918-1993), Albert King Aldrich (1925) and George Masters Aldrich (1932).

In 1919 Aldrich moved to the Rio Grande Valley and lived in San Juan, Texas until 1930 when he moved his family to Edinburg, Texas. He was a senior partner in the law firm of Aldrich, McDonald, and Stewart.

Aldrich served as Hidalgo County District Attorney from 1929 through 1930 and as Hidalgo County Judge from November 3, 1936 until November 15, 1940. His other community involvement included memberships in the First Presbyterian Church of Edinburg, the Masonic Lodge, Edinburg Rotary Club, the American Legion, the Hidalgo County Bar Association, the State Bar of Texas, and the American Bar Association.

Aldrich died in Edinburg on September 18, 1965 and was buried at Hillcrest Memorial Park in that city.

Oliver Cromwell Aldrich, Jr., was born on November 11, 1918 in Houston County, Texas. He married Alice (Statham) Aldrich (1921-2011) in 1941. Their children were Oliver Cromwell Aldrich, III, Albert Aldrich, Collin Aldrich, and Cathleen (Aldrich) Miller.

Aldrich attended Edinburg High School and was in the marching band in 1932. He attended Texas A&M in the mid-1930s. He was a farmer and construction contractor and owned a crop dusting company.

During World War II Aldrich served in the Texas Defense Guard as a Sergeant in the First Platoon in Company F, 31st Battalion headquartered in Mission, Texas. His commanding officer was Major Lloyd M. Bentsen.

Aldrich died on March 2, 1993, in Houston, Harris County, Texas. He is buried at Hillcrest Memorial Park in Edinburg, Texas.

SCOPE AND CONTENT NOTE

The interests of Oliver Cromwell Aldrich, Sr. and his son Oliver Cromwell Aldrich, Jr. are documented in this collection. Topics covered include music and lyrics, fishing, automobiles, cameras, flying and air planes, boats, agricultural equipment, politics, law, and World War II. Formats found in the collection are brochures and booklets, political campaign flyers and speeches, military documents, music, published materials, maps, artifacts, and memorabilia. Items of interest include music lyrics written in Spanish; a speech for the Hidalgo County Judge campaign in 1938; Texas Defense Guard drill assignments, guard posts descriptions, and plans and training used during World War II; and a land title record for the Alamo Land and Sugar Company, a subdivision of Porcion 72 (1915). Most of the maps in the collection concern irrigation and waterways.

The artifacts in the collection consist of an Edinburg High School marching band uniform, American Legion and ROTC uniform items, and various other personal items.
