BIOGRAPHICAL/HISTORICAL NOTE

Charles Vale Mayes come to Edinburg, Texas in 1937, as sales and traffic manager for H. Rouw Co. of Van Buren, Arkansas. Rouw had four large sheds for both citrus and vegetables in Edinburg.

In 1950 Mayes and associates, Ralph Dunavant, W.H. "Pete" Utz and Warren White, bought the Polis & Hagan Co. operating as Vale Mayes & Co. The serious 1951 freeze destroyed about three fourths of the citrus trees necessitating conversion to mostly vegetables and cantaloupes. The firm was in the citrus business for the next seven years, and then began shipping vegetables and cantaloupes only. In 1956 the Southern Pacific Railroad built a shed for the Mayes firm on East Schunior. After Mayes's retirement in 1973, Paul Jackson, Jr., Mayes's son-in-law, became president and Robert Vale Mayes, his son, became vice president. When Jackson and Robert Mayes retired, the facilities were sold to Joe Vasquez Produce Co. Vasquez's brand was Senora Sandia.

Mayes was active in the Texas Fruit & Vegetable Growers & Shippers Association from its inception in the early 1940s, serving as president in 1952 and director several times. He is listed in the Texas International Produce Association's Hall of Fame as an industry member who made contributions in support of the Texas produce industry and provided motivation and leadership continuity.

Mayes was born on October 4, 1906 in Johnson, Arkansas to Charles Stinson and Lillie Ellen Slauter Mayes. He married Georgia E. Boss on January 22, 1928 in Anderson Missouri. During his youth and early adulthood, Mayes lived in Arkansas, Iowa, and Oklahoma.

As a member of First United Methodist church in Edinburg, Mayes served on many advisory boards. After his retirement, he and his wife divided their time between their homes in Shell Knob, Missouri and Edinburg, Texas. Mayes died on December 26, 2002 in Kerrville, Texas where he lived with his daughter and son-in-law Patsy and Paul Jackson, Jr. He is buried in Hillcrest Cemetery in Edinburg, Texas.
